6. ANNUAL REPORT

A. ANNUAL REPORT 2019/20

GENERAL OVERVIEW OF ACHIEVEMENTS

The Mayor tabled the Annual Report and made reference to the Mayor's message contained therein and provided a general overview of Council's challenges, achievements and highlights which occurred during 2019/20.

The Mayor conveyed his appreciation to Aldermen, the General Manager and Staff for their support to the residents of Clarence.

B. PRESENTATION OF COUNCIL'S 2018-2019 FINANCIAL REPORT

The Chief Financial Officer gave a detailed overview of the Financial Statements in the Annual Report and Council's overall financial performance and answered questions arising.

Ald James asked the following questions:

Ouestion 1

The actual monies that are sitting in cash you advised were \$25M and also I would like clarification about the \$7M that is actually sitting in one of our accounts in relation to the Seven Mile Beach sporting precinct and also a \$14.5M amount that the State Government provided to the Council on loan as part of the COVID-19. My direct question to you is are any of those monies that are either in cash or in that loan account from the State Government or in the Seven Mile Beach sporting precinct, if Council decides to initiate a buy back from Chambroad Petrochemicals are any of those funds I just outlined able to be provided if a decision is made to buy back the land from Chambroad Petrochemicals?

Answer

With regard to the loan amounts they actually relate to the 2020/21 financial year and were part of Council's estimates so in terms of the financial statements here I cannot actually answer that question for you this evening. The Seven Mile Beach sporting precinct was I understand a Council approved decision in terms of taking on loan money to support the development of that. I do not believe that has progressed and we have not taken the amount up for that amount. The \$25M cash that I mentioned is unrestricted which means it is actually supporting working capital so it is going to be supporting the on-going operations of Council.

Ouestion 2

At the time the budget was finalised in July this year there was an austere budget constraint put upon Council for the 2020/21 financial year. Given that there has been an expected greater inflow of revenue post the budget and there is a value associated with that of \$.5M what funding would that be made available to or can that funding support any benefit that would flow to the ratepayers of the City of Clarence?

Answer

Again with reference to your question being one of budget estimates for the 2020/21 financial year given the focus for this evening is the 2019/20 financial year I am not actually in a position to answer that question however I am prepared to take that on notice and prepare a response accordingly.
