Underpinned by the following key organisational goals:



Budget 2023-24

Clarence City Council adopted its budget for 2023-24 Financial Year in June, with key road, infrastructure, and facilities projects prioritised.

This year council placed a particular focus on the important balance between ensuring Clarence continues to grow and thrive, while also being mindful of the pressure of rising costs of living felt by residents, ratepayers and businesses.

The 2023-24 budget provides a capital works program of \$28.9 million for renewal and new capital works, which is a sizable increase from last year and is part of council's forward planning to ensure our city is maintained for years to come. This brings the ongoing capital works program approved by council close to \$55 million.

Clarence Community Spirit Gala and Citizenship Awards

To coincide with National Volunteer Week, Clarence City Council held its second ever Clarence Community Spirit Gala and Citizenship Awards ceremony on Tuesday 16 May at Blundstone Arena.

The gala was brimming with volunteers, family and invited guests from all corners of Clarence, representing a diverse cross-section of the community, with involvement in a wide range of organisations.

From the 64 highly deserving nominees, six Clarence City Council Citizenship Awards were presented to outstanding candidates for their contributions to the Clarence Community.

City Heart

This quarter, council undertook further consultation on its City Heart Plan with the release of the City Heart Draft Concepts.

The community was invited to comment on the design of the expansive City Park, urban development, social and affordable housing, and better connecting Warrane, Rosny and Bellerive.

Consultation closed in early May, with council and consultants continuing to work to further develop the plan.

Through the release of concept drawings, the City Heart team heard valuable feedback on key issues including housing, connectivity, and economic development, as well as how improvements might be achieved.

The future management and activation of large expanses of open space will be key to creating the 'green' heart of the city the community desires, while also creating attractions and spaces for everyone.

Consultation

Council undertook five public consultations this quarter with approximately 6,000 users visiting the Your Say Clarence website for more information, with 755 of those visitors providing consultation feedback on the platform. A further 700 residents and businesses engaged through an external research partner.

The Draft Victoria Esplanade and Queen Street Master Plan consultation ran for six weeks, concluding on 14 May and included an online survey and series of pop-up consultation sessions.

During the quarter, council partnered with respected local research agency EMRS to undertake the Living in Clarence: Community Survey- a comprehensive, representative community survey. The purpose of this survey was to help better understand what the community valued about living in Clarence, their perceptions of both the city and council, and what it is like to live in Clarence. The results of this survey will help inform council strategies.

The Draft Cambridge Oval Master Plan engagement concluded on 21 May, council heard from many residents in the surrounding area, visitors to the oval and the local Primary School. Consultation results will be released in the second half of 2023.

Council held an onsite information session for the Pindos Park Redevelopment on 5 April which was well attended by local residents and park visitors. Tender for the construction of the park closed in May with a tender expected to be award in July and construction expected to begin in September 2023.

Council also held its Fitness in the Park Annual Review this quarter, checking in with Fitness in the Park participants to see how the program could improve in the next financial year.

Consultation on the Richmond Village Master Plan also began this quarter and will be concluded during next quarter.

Governance

In April, council voted to restructure its special committees, following the approval of several key strategies over the past year.

The new structure established five Advisory Committees and six Standing Working Groups (reporting to a nominated advisory committee).

The establishment of Advisory Committees and Standing Working Groups will allow for better collaboration and administrative efficiency, and better align with the strategic direction of council.

Also in April, council voted to no longer hold citizenship ceremonies or community events on 26 January. In accordance with the Australian Citizenship Ceremonies Code, from 2024 the January citizenship ceremony is to be held in the three days prior to, or the three days after 26 January.

Council's Citizen of the Year awards ceremonies will remain in the same format (Citizen of the Year coupled with Volunteer recognition event held in May) however will be permanently decoupled from Australia Day.

Environmental Health

Howrah Beach water quality

This quarter, the Derwent Estuary Program released its Recreational Water Quality Annual Report 2022-23 showing the water quality at the middle of Howrah Beach and at the west of Bellerive Beach improving markedly.

Both Howrah Beach (mid) and Bellerive Beach (west) had their long-term water quality ratings upgraded as a result of council's focus on improving water quality, along with strong support from TasWater.

Public education on stormwater pollution, appropriate remediation, and intervention measures upstream of the beach, will continue in the 2023-24 financial year.

Following the investigative works at Howrah and Bellerive beach, council is now better prepared to respond to future pollution events and mitigate any future risks to public health.

Council Chambers celebrates 50 years

Council proudly celebrated the 50th anniversary of its iconic chambers in April, ahead of a new evolution for the award-winning building.

The building was opened on 16 April 1973 and represents a significant milestone in the municipality's history and growth.

The outstanding design of the Clarence City Chambers, which utilised local materials, space, and landform, created a strong civic identity for the expanding community at that time.

The building has received multiple awards over the past 50 years, including the Australian Institute of Architects (AIA) – Triennial Award for Public, Educational, Religions and Sporting Buildings in 1975 by the Tasmanian chapter, and most recently the prestigious AIA Enduring Architecture Award in 2022, again by the Tasmanian chapter. It was also nominated for a National Architecture Award in the Enduring Architecture category in 2022.

Story Festival 2023.

As part of this year's budget process, council allocated funds to develop plans for the redevelopment of the Council Chambers and Bligh Street council offices, including landscaping of the surrounding area.

The redevelopment will improve accessibility for the community and staff, as well as creating the additional space required to house our growing team in a contemporary office space. The design will complement the City Heart vision which is for a people-friendly civic and employment hub which is better connected to Bligh Street and the Rosny Parklands.

Arts and Events

Story Festival

Clarence City Council's annual Story Festival returned in May for a week-long celebration of community, diversity, and cultural sharing.

Following from last year's triumphant inaugural event, the 2023 festival built on the success of the previous event to deliver a diverse and jam-packed program of workshops, stalls, performances, shared meals, and cultural exchanges.

This year participants learnt to make gnocchi with an Italian master matriarch, write elegant Japanese calligraphy, develop delicious dumpling skills, or henna their hands.

Most of the festival was held at the Grace Centre in Rokeby to help spread social and economic benefits more widely throughout Clarence.

Works

takara limuna opening

In celebration of National Reconciliation Week, council proudly announced the opening of takara limuna (Sheoak Walk), a new walking trail exploring the rich Aboriginal cultural history of the Bedlam Walls Reserve in Geilston Bay in June.

Accessed via the Shag Bay track, the 700 metres stretch leads to the headland of Bedlam Walls with the trail featuring five interpretation panels, a viewing platform, and a central firepit and gathering circle.

As well as honouring the stories, history, and culture of the Mumirimina people, this new trail pays homage to the continuing connection of the Tasmanian Aboriginal people to Country, culture, and community.

The name of the trail is taken from palawa kani and refers to the limuna (Sheoak tree), a native plant species which is endemic to the Bedlam Walls Reserve. The interpretation panels were written and researched by Aboriginal Cultural Practitioners Theresa Sainty and Zoe Rimmer, designed by Alex Miles and illustrated with artwork by Tasmanian Aboriginal artist Allan Mansell. The panels also feature QR codes to recordings and written words telling the stories in palawa kani.

Two years in the making, and the culmination of hard work and collaboration across multiple council teams and external consultants, this project was made possible through collaborative funding between the Clarence City Council and the Tasmanian Government's Election Funding Commitment Grants round.

South Arm play space

Construction of a new play space at South Arm Oval started in the quarter with works on track for completion later in 2023.

The new play space will feature engaging play equipment including a trampoline, swing set, climbing tower, slide, picnic area, garden beds and an adventure explorer track.

The latest edition to network of trails at the ever-popular Clarence Mountain Bike Park, Flow Monster, was completed this quarter.

The Flow Monster track boasts 1.3km of big berms and a super flowy ride suitable for all abilities. The track is accessed via the XC Climb next to the concrete slab area and was constructed with funding from the Federal Government's Building Better Regions Grant.

naniyilipata/Clarence Plains Historical Trail

The naniyilipata/Clarence Plains Historic Trail in Rokeby was officially launched in May by former Clarence City Council Mayor Doug Chipman, whose family moved to the Clarence Plains area in 1808.

The trail was developed by members of Tranmere and Clarence Plains Land and Coastcare Inc (TACPLACI) with funding from the Tasmanian Community Fund and assistance from Clarence City Council.

The trail starts from St Matthews Church opposite the Rokeby Village Green on North Parade and visits sites of historical interest around the Clarence Plains area. The walk takes around two hours to complete the 4.5km trail, it can also be walked in shorter sections.

Community Development

Warrane Basketball stadium mural

The Warrane Basketball Stadium received a major facelift this quarter with the completion of a new large-scale mural by well-known Hobart artist Tom O'Hern.

Commissioned by and created in collaboration with Clarence City Council as part of council's ongoing work to reduce tagging and graffiti in the community, the work has elicited a huge positive reaction from locals and visitors to the stadium.

The work is entitled 'Rampage' with artist Tom O'Hern explaining his inspiration as coming from a mix of local and nostalgic sources.







Council's 'Our Shared Space' program joined with Families Tasmania to celebrate National Families Week and the United Nations International Day of Families in May with a Snack and Sing in the Garden event held at the Warrane Mornington Community Garden.

This is the first time council has opened an intergenerational event like this to the wider community.

The event was well attended by people of all ages who enjoyed a range of activities including singing songs inspired by nature, a treasure hunt, weaving, making nature crowns and wands and creating pebble art.

Family Services

Rosny Early Learning

In June, Rosny Early Learning invited the Wren, Penguin, and Possum rooms to join a DARK MOFO gathering, called DARK ROFO (R for Rosny). All the children gathered in the dining room to enjoy morning tea surrounded by decorations they had made previously.

To prepare for their DARK ROFO winter feast, the children all had the opportunity to create crowns with dried leaves and lights using recycled bottles. These craft activities invited children to think creatively and use their skills of design, and higher order thinking.

As well as supporting the use and development of these skills, there are other benefits that link to the EYLF (Early Years Learning Framework) such as, strengthening and maintaining relationships, encouraging practice of different forms and methods of communication, creating awareness and knowledge of happenings and occurrences within their community and lastly, links to sustainability through the inclusion of recycled products for crafts.

During the winter feast the children enjoyed some special morning tea, and sat around together on cushions and rugs surrounded by red lights, friends, leaves, educators, and their amazing pieces of art. There was some discussion around the concepts of light, dark and shade/shadows.

MAJOR STRATEGIC PROJECTS AND INITIATIVES

There are several key projects and initiatives identified as priorities for council in its Strategic Plan 2021-2031. These projects are significant in their nature and involve long term commitments by council. This section of the Quarterly Report provides a more detailed update on these projects and initiatives, despite them also being referenced and referred to in the strategic goals area tables.

City Deal

Council continued to work as part of the Greater Hobart Committee over the course of the quarter to work towards the 10-year vision of the City Deal.

Bayview Regional Sporting Precinct

After the Master Plan was approved by council in October 2021, council undertook a detailed feasibility study and business case, to understand the development in greater detail, and provide a solid case to proceed.

The business case was completed this quarter and will be presented to Councillors at the July 3 Council Workshop.

Pending council approval, key stakeholder and community consultation on the findings of the business case is expected to commence in the second half of 2023.

Council is preparing a funding bid through the Federal Government's 'Thriving Suburbs Program'. This program is expected to be available for applications in 2024-25.

City Heart

MGS Architects were engaged in September 2022, with subconsultants Inspiring Place, SGS Economics and Planning, Sharnie Read, Mosaic Lab, Irene Inc., Leigh Woolley, Movement and Place Consulting, and WT Partnership making up the team.

Community engagement was undertaken as part of the project in the second quarter with the key directions report and consultation outcomes reported back to community in December 2022.

Early in 2023 the consultant team developed several concepts for the study area, based on the key directions report and consultation outcomes. These concepts were workshopped with Councillors before going out to community consultation for six weeks from 19 March 2023.

It is planned that a final draft City Heart Plan will be ready for endorsement by Council for final community consultation in August 2023.

Clarence Plains Master Plan

Consultation on the draft Master Plan was undertaken throughout the end of the quarter and into the second quarter. The report from this phase was provided to the consultants and elected members on stakeholder and community feedback, as well as made publicly available in December 2022.

Officers have been undertaking an internal review and working with key stakeholders to draft priority recommendations to go with the final Master Plan for council adoption in the third quarter of 2023.

Kangaroo Bay Development Precinct

Kangaroo Bay Boulevard

Council approved a development application for the Kangaroo Bay Boulevard site at a special council meeting on 8 November 2021. Sale of the land is currently being negotiated with the developer.

Kangaroo Bay Wharf Site

At a meeting on 20 March 2023 council reaffirmed its decision of 23 January 2023 to authorise the Chief Executive Officer to initiate the buy-back of the land from Chambroad. This process is now underway.

Rosny Hill

Council continued to negotiate with the proponents on key sub-lease terms for the Rosny Hill site during the quarter.

Tranmere/Rokeby Peninsula Structure Plan

This project is currently on hold. The Minister for Planning approved the removal of the Urban Growth Boundary that applied to Droughty Point. Officers are assessing the consequences of this change.




Kerbside green waste






Tree removal applications and enquiries



Total kerbside and Transfer Station waste (tonnes) collected from Clarence households




Kerbside hard waste collection







Unsealed length of road graded






Vandalism and graffiti expenditure comparison












Planning and subdivision – average processing time






