Child Development

- Developing an increased understanding of the individual needs of each child.
- Undertaking work with individual children with additional needs, as required.
- Support and guiding children's behaviour in a positive manner.

Medical, Health and Safety

- Undertaking safety checks of all children's areas.
- Reporting equipment and maintenance needs to supervisory staff and removing broken or potentially dangerous toys and equipment.
- In the case of a child's illness or (serious accident) accident or incident, ensuring information is passed on to senior staff or the Director immediately.

General

- Attending staff meetings and in-service training as required.
- Working with other staff members and management in a co-operative manner.
- Ensuring open and positive communication is maintained at all times between staff, families, management and children.
- Role model and maintain the regulatory requirements across educational and care services.
- Ensure staff and children utilise effective health and hygiene practices, including meeting all regulations relating to food safety and preparation, medical management plans, and risk management plans, policies and procedures.
